This has reference to your letters/representations/complaints received by us. Your letters have been perused and examined with following remarks:

i. Allegations of appointment / promotion of Executives with forged/fake degrees in BEL:

Based on your complaints, BEL Corporate Vigilance has examined the cases of the above subject matter and replying to you that the candidates appointed / promoted possess the requisite educational qualifications as per advertisement and that your allegations are unfounded and not based on facts vide Corporate Vigilance Letter: Ref: 21328/0211/BEL/NAMU/14-15 dt: 18th December 2014.

ii. Despite wherein the subject has been disposed of previously and duly, again approaching yourself to the Hon'ble Ministers, Cabinet Secretariat, Hon'ble Prime Minister and Hon'ble President of India to initiate CVC / CBI enquiries / file FIR against officials of Department of Defence Production and BEL and also inform of action taken:

It is noticed that your approach to RTI complaints is abusive, irresponsible, vindictive and indulgent towards authorities of BEL. The CMD, Directors, CVO and MoD officials whom you are targeting were never been involved and related on the issues of your complaint. It is gross violation and misbehaviour on your part which will be taken up as defamation of institutions and individuals.



iii. Ruling by the Central Information Commission under RTI Act, 2005:

It is pertinent to mention that your habitual misbehaviours and mis-fitness to be a sane person. The Central Information Commissioner vide it's decision in File No. CIC/CC/A/2014/001185 and 86/SD dated 29-06-2016 has observed that you have made as many as 148 RTI applications in Ghaziabad unit and 155 applications in Corporate Office of BEL on same and similar grounds and has concluded that you are habitually taking the RTI route for harassing the public authority and also pursuing personal vendetta. It is also noticed that you were cautioned by the CIC "for misusing the provisions of the RTI Act while observing that a beneficial statute when made a tool for mischief and abuse must be checked in accordance with law ...the appellant who is a retired employee of BEL had sought information not for any public interest or to bring any transparency in the system but for settling personal scores with officials of his earlier Organisation. Commission cannot allow any appellant to make insinuating, defamatory and unparliamentarily remarks against the Commission".

iv. From the examination of documentary evidences and Ruling of CIC, it is observed that there is no sanity and merit in your complaints and you are advised not to make any baseless allegations on the aforementioned subjects in future. In case if you continue to make such unfounded allegations, the concerned authorities of BEL may be advised to take up appropriate legal actions, as deemed fit.
